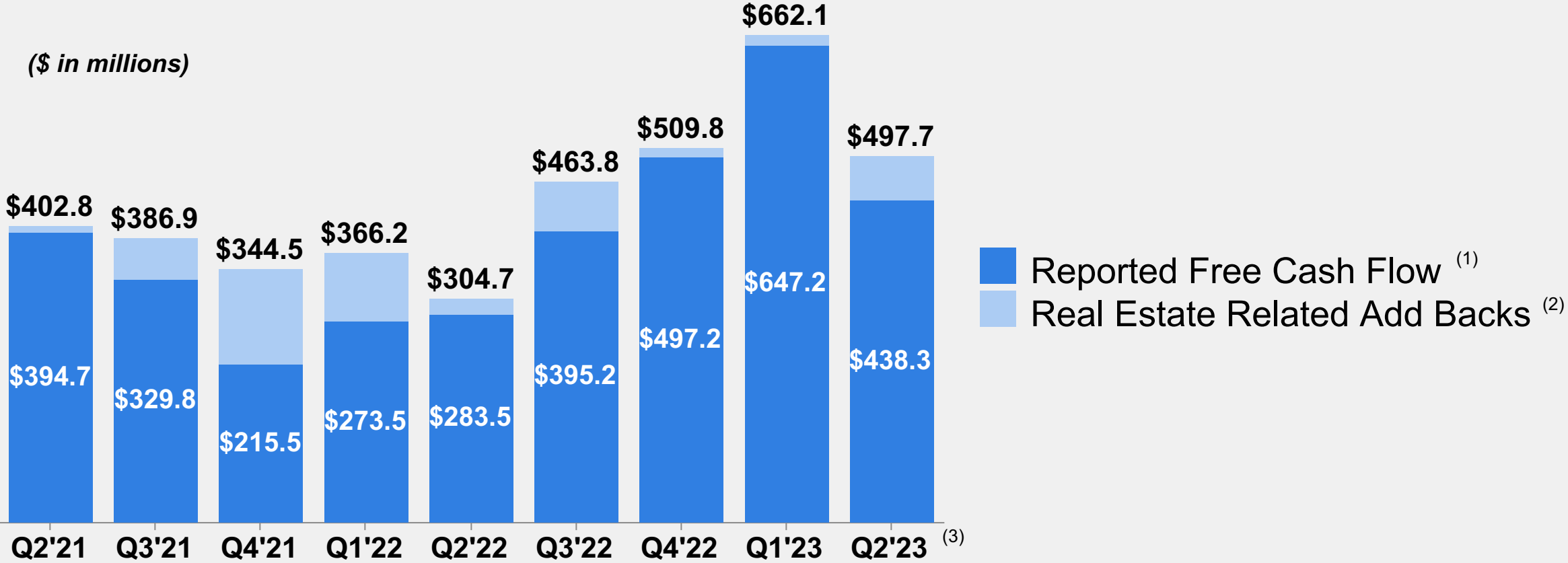

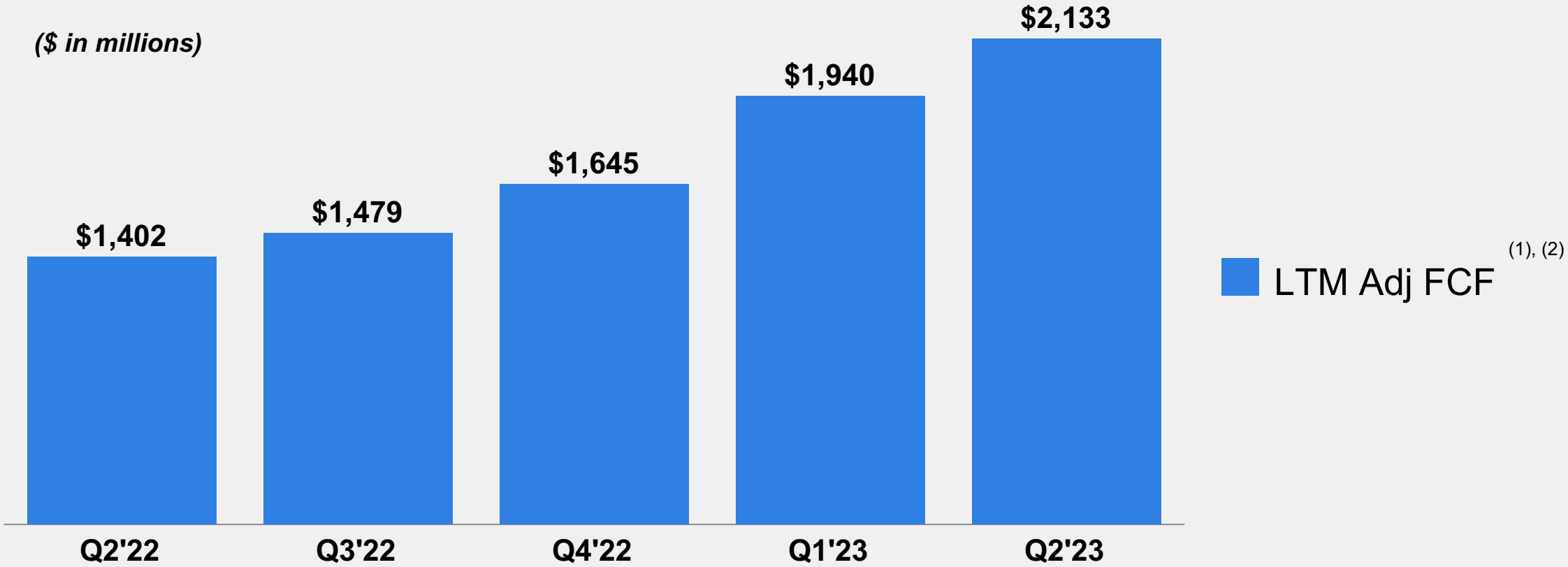

# LTM Adjusted Free Cash Flow

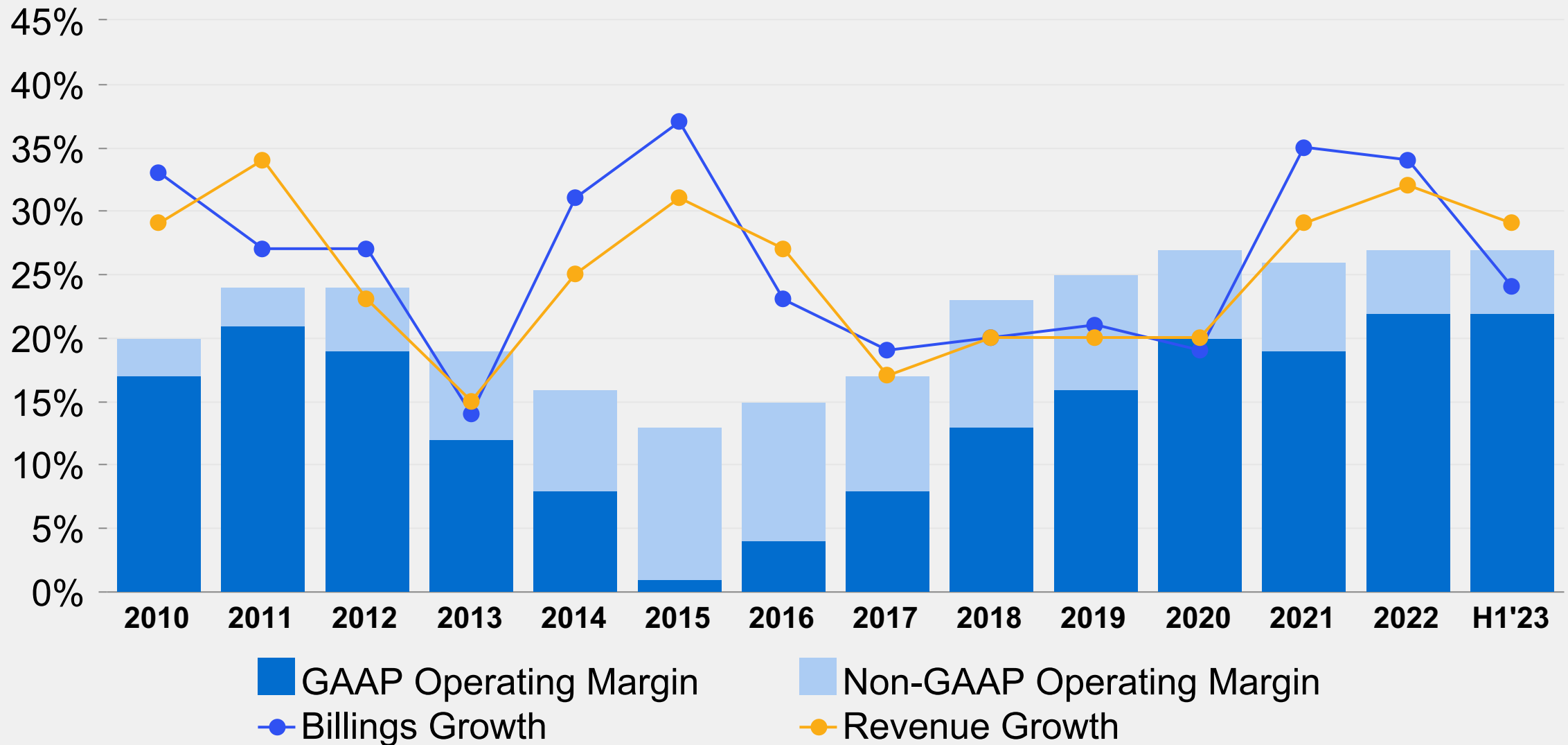
